

OFFICIAL "TAX CHECK CASHING" SWEEPSTAKES GAME RULES AND REGULATIONS

1. NO PURCHASE OR PAID TRANSACTION NECESSARY TO ENTER OR WIN.

Open to legal residents of the state of New York, age 18 or older, except employees of RiteCheck Financial Services, Inc. ("Sponsor"), and its subsidiaries, participating vendors, advertising and promotion agencies and affiliated entities (collectively, the "Sweepstakes Entities") and the immediate families (parent, child, sibling and their spouses) and household members of such employees. Void wherever prohibited by law. Sweepstakes is governed by U.S. law and subject to all applicable federal, state and local laws and regulations. Entrants agree to accept and be bound by all terms of these Official Rules and Regulations and the decisions of the judges, which are final and binding in all matters.

2. HOW TO ENTER: Between February 15, 2017 – April 30, 2017 (the "Sweepstakes Period") Sponsor will conduct an Enter-to-Win Sweepstakes ("Sweepstakes") in participating RiteCheck stores operating throughout the New York metro area. When an eligible entrant cashes a Tax Refund Check at a Sponsor's retail location, the entrant will be automatically entered into the sweepstakes. To enter without making a transaction, send a 3" x 5" index card between February 15, 2017 to April 21, 2017 containing entrant's legal name, address and telephone number postmarked no later than April 21, 2017 to: Tax Check Cashing Sweepstakes, RiteCheck Financial Services, 715 East 138th Street, Bronx, NY 10454. All entries must be in the name of a living individual or person. No other form of entry will be accepted. In the event of sabotage, acts of God, terrorism, or other events or causes beyond the Sponsor's reasonable control, which corrupt the integrity, administration, security or proper operation of the Sweepstakes, Sponsor reserves the right to cancel, modify, or suspend the Sweepstakes. In the event of cancellation, the prize will be awarded from among all eligible, non-suspect entries received prior to the event requiring such cancellation. False or deceptive entries or acts will render a participant ineligible. All entries become the property of Sponsor and will not be acknowledged or returned. **No purchase entries limited to one (1) per person/per household.**

3. SWEEPSTAKES PRIZES: One winner per drawing will be selected by random drawing from all of the eligible entries. Odds of winning depend on number of entries received. Whether or not entrant cashed a Tax Refund Check through sponsor's location will not affect odds of winning. Grand Prize will consist of Sponsor paying winner a sum of \$3,000, winner to be notified no later than June 1, 2017. Weekly \$200 prizes will be drawn for a period of eight (8) weeks from February 15, 2017 to April 12, 2017. \$200 prize winners will be notified weekly. No transfer of prize permitted by winner. No substitution, except as provided for herein. Winner is responsible for the reporting and payment of all applicable federal, state and local taxes on prize. Sponsor is not responsible for incorrect addresses, inaccurate or incomplete information submitted by customer at time of making bill payment or providing alternate form of entry.
